1. Mr. Naphade states that he is ready with submissions in reply to this MA,

but seeks to rely on a further compilation of documents. The compilation of documents is not before this court. On the last date, Mr. Sharma had appeared on behalf of these respondents and was to respond today. Mr. Cooper objects to production of new documents at this stage especially he has been served with a compilation only this morning.

- 2. This application, just as the others in this group, is seeking payment of interest. The principal sum has already been paid to the bank. The record indicates that on 1st December 2009, an affidavit dated 26th November 2009 on behalf of respondent no.2 is already on record. When this matter was listed for hearing on earlier occasions, at the request of the respondent no.4A, a further affidavit was permitted to be filed. That affidavit is of respondent no.4A and is said to be filed on behalf of himself and as legal heirs of late Smt. Rasila S. Mehta and the respondent no.2. The affidavit runs from pages 36 to 128. It annexes documents including pleadings in other matters and in all runs into 496 pages. A compilation is not even before the court. The objection is therefore justified. In that view of the matter, Mr. Naphade agrees to proceed with and concluded his submissions.
